## OFFICIAL STATUS OF CONSOLIDATIONS

Subsections 31(1) and (3) of the *Legislation Revision and Consolidation Act*, in force on June 1, 2009, provide as follows:

### Published consolidation is evidence

**31 (1)** Every copy of a consolidated statute or consolidated regulation published by the Minister under this Act in either print or electronic form is evidence of that statute or regulation and of its contents and every copy purporting to be published by the Minister is deemed to be so published, unless the contrary is shown.

### Inconsistencies in regulations

**(3)** In the event of an inconsistency between a consolidated regulation published by the Minister under this Act and the original regulation or a subsequent amendment as registered by the Clerk of the Privy Council under the *Statutory Instruments Act*, the original regulation or amendment prevails to the extent of the inconsistency.

## Regulations Respecting Prescribed Brands of Manufactured Tobacco and Prescribed Cigarettes

### Intpretation

**1** In these Regulations, **Act** means the *Excise Act, 2001*.

### Prescribed Brands of Manufactured Tobacco

**2** The brands of manufactured tobacco set out in Schedule 1 are prescribed brands for the purposes of subsection 38(3) of the Act.

### Prescribed Cigarettes

**3** Cigarettes exported under a brand set out in Schedule 2 are prescribed cigarettes for the purposes of paragraph 38(4)(a) of the Act.

### Coming into Force

**\*4** These Regulations come into force on the day on which section 4 of the *Regulations Amending the Stamping and Marking of Tobacco Products Regulations (2011)* comes into force but if they are registered after that day, they come into force on the day on which they are registered.

### Définition

**1** Dans le présent règlement, **Loi** s'entend de la *Loi de 2001 sur l'accise*.

### Appellations commerciales de tabac fabriqué

**2** Sont visées, pour l'application du paragraphe 38(3) de la Loi, les appellations commerciales de tabac fabriqué figurant à l'annexe 1.

### Cigarettes

**3** Sont visées, pour l'application de l'alinéa 38(4)a) de la Loi, les cigarettes exportées sous une appellation commerciale figurant à l'annexe 2.

### Entrée en vigueur

**\*4** Le présent règlement entre en vigueur à la date d'entrée en vigueur de l'article 4 du *Règlement modifiant le Règlement sur l'estampillage et le marquage des produits du tabac (2011)* ou si elle est postérieure, à la date de son enregistrement.
